



# Fire Sprinkler Plan Review

**PURPOSE:** This two-day seminar provides attendees with vital information on how to conduct the plan review process for water-based fire protection systems. Utilizing the requirements of NFPA 13 the participant will be guided through an actual review of sprinkler system plans and calculations. They will discuss the importance of employing a systematic review process and identify the documents required for a complete plan review. Finally they will review a submittal of hydraulic calculation presented with the plans and discuss the process of hydraulic calculations and identify the key pieces of information presented and the common errors that are made.
